Dead end signs, Ernie called M&R sign, \$46-47 per sign. Supervisors to look at signs that need to be replaced and then make an order after the next meeting.


Treasurer's Report \$139,480.96 spent \$29,332.94 balance \$110,148.02 last year's balance \$ 114,165.71.
